Organizational Background

MTG is a pioneer in football for girls' empowerment in Kenya's Coast Region. Started in 2002 in Kilifi, the women-led organization works towards a fair, just and inclusive world where girls and young women's rights are acknowledged, respected and realized. It employs a rights-based and sports (football) approach and focuses primarily on education, sexual and reproductive health and rights, economic empowerment and leadership development. By positively influencing and equipping communities to provide safe spaces and opportunities for girls and young women, MTG contributes to the facilitation of girls to achieve their full potential. More than nine thousand girls (aged 9 – 25 years) participate in MTG programming annually in Kilifi, Mombasa, Kwale and Tana River counties.

Introduction:

MTG is soliciting proposals from qualified firms/individual to review and facilitate the review of the Reproductive health Curricula. The consultant with the Reproductive health team will Review, Update and Revise the curricula while incorporating emerging trends and information, use of illustrations and easy to comprehend messaging.

- To provide a complete Health Curricula with disaggregated sessions for different ages categories with guiding notes on sessions for participants in accordance to the years they have been in engagement with MTG.

Proposal outline

Submissions are to include the following:

- A cover letter, signed and dated, summarizing the qualifications of the consultant to engage in this project.
- References of previous similar projects undertaken
- A profile of the consultant(s) to be assigned to this assignment (key contact person for the engagement, complete CV of the individuals assigned as an appendix to the submission).
- An outline of fees which will include detailed information on all expenses required and all contractual information.
- A recent certificate of Good Conduct.
- A workplan outlining the tasks – (should be delivered within 30 working days)
- Dissemination of the final curriculum including training of the staff within 60 working days.

Key Deliverables

- To come up with an inception report detailing the literature review, methodology and workplan of the assignment.
- Draft Curricula for feedback and comments.
- Final Curricula and clear framework of work-flow for implementation.
- Facilitate a training workshop with a complete report on all the deliverables.
